MedStar Presentation on Hands Only CPR at August General Meeting

MedStar has begun hosting chest compression training sessions at community events, city meetings and area businesses in the hope of increasing the public's ability and willingness to aid cardiac arrest victims. Considering that heart disease remains the top cause of death in the US, learning chest compressions is definitely time well-spent!

The training includes a short tutorial and hands-on instruction with a MedStar professional. Please note that attendees of this type of training will not receive official CPR certification. However, early and effective chest compressions can be performed by bystanders and are proven to substantially increase survival rates for cardiac arrest patients.

MedStar will present this information at our August 13 General Meeting. Make plans to attend.
